# Memorandum of Understanding

Between the Indian Institute of Skill Development (IISD) and St. Xavier's College,  
Mahuadanr for the EXCEL Project

This Agreement made and entered into on this 26<sup>th</sup> December 2023 at Ranchi Jharkhand, India by and between: -

**INDIAN INSTITUTE OF SKILL DEVELOPMENT PVT. LTD.** is a company having its registered address **A-06, Info city Part 1, Sector 34, Gurgaon – 122001, Haryana** of the **"FIRST PARTY"**. **INDIAN INSTITUTE OF SKILL DEVELOPMENT PVT.LTD.** is engaged in the business of providing conducting Skill Development Initiative (SDI) Projects of Corporate Sector/NSDC/SSC, State Governments in various States.

AND

**Second Party St. Xavier's College, Mahuadanr**, its registered office at **Arrupe Niwas, Distt- Hazaribag, Jharkhand** is Authorized person **Dr. Fr. M. K. Jose SJ, S/o/D/o Mr. Kurien** (hereinafter referred to as **"Associate"** which expression, unless repugnant to the context or meaning thereof, shall be deemed to mean and include its successors, administrators and permitted assigns) of the **"SECOND PARTY"**.

The term "Party" here shall mean **INDIAN INSTITUTE OF SKILL DEVELOPMENT PVT. LTD.** 'or **'ST. XAVIER'S COLLEGE, MAHUADANR** and the term "Parties" shall mean both **INDIAN INSTITUTE OF SKILL DEVELOPMENT PVT.LTD.** and **ST. XAVIER'S COLLEGE, MAHUADANR** collectively.

WHEREAS **INDIAN INSTITUTE OF SKILL DEVELOPMENT PVT.LTD.** is an organization which is empanelled as Training Provider with Jharkhand Skill Development Mission for execution of EXCEL projects (herein after referred as **'EMPLOYABILITY EXCELLENCE WITH COLLEGE EDUCATION AND LEARNING UNDER MUKHYAMANTRI SARTHI YOJANA'**) and has undertaken the work of carrying out training activities at the Training Centre of the Associate based on the eligibility required by them which has been complied by the Associate Centre.

AND WHEREAS Associate is an organization which is capable of providing a training execution having all kind of expertise in developing and managing skill development project in the area specified herein above.

AND WHEREAS the said Associate has approached **INDIAN INSTITUTE OF SKILL DEVELOPMENT PVT.LTD.** and expressed his interest to build the training business

together with certification, good quality in delivering training program, academic content and its process, as well as strong linkages for growing rapidly in training industry. **INDIAN INSTITUTE OF SKILL DEVELOPMENT PVT.LTD.** and Associates have explored the possibility of collaborating together for long-term objective of building the training business at a mutually desired level, based on the terms and condition as mutually agreed upon herein under.

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

Following are the broad terms and conditions being agreed upon while executing this Agreement:

1. That this Agreement shall be valid upto the period of next five years start as specified "Annexure-A" or during the terms of the Project, whichever is earlier, which may be extended as per the mutual discussions with the both parties if required.
2. That during the term of this Agreement, **ST. XAVIER'S COLLEGE, Mahuadanr** shall provide Specified Job Roll wise Infra with proper running condition to **INDIAN INSTITUTE OF SKILL DEVELOPMENT PVT.LTD.** and also agrees that in case of damage, breakage of any equipment, the same shall be repaired/ replaced by **INDIAN INSTITUTE OF SKILL DEVELOPMENT PVT.LTD.** Further, it is agreed between the Parties hereto that in case, electricity is required then, it shall also be arranged by the **ST. XAVIER'S COLLEGE, Mahuadanr.**
3. That in case of any modification or amendment is required relating to the terms and conditions of this Agreement, it shall be done by the mutual consent of both the Parties i.e. **INDIAN INSTITUTE OF SKILL DEVELOPMENT PVT.LTD.** and **ST. XAVIER'S COLLEGE, Mahuadanr.**
4. That during the term of this Agreement if, for any reason, **INDIAN INSTITUTE OF SKILL DEVELOPMENT PVT.LTD.** and intends to change the structure of space (including equipment) then it shall intimate, well in advance, to **ST. XAVIER'S COLLEGE, Mahuadanr.** **INDIAN INSTITUTE OF SKILL DEVELOPMENT PVT.LTD.** only upon approval of **ST. XAVIER'S COLLEGE, Mahuadanr,** such changes would be implemented by **INDIAN INSTITUTE OF SKILL DEVELOPMENT PVT.LTD.**
5. That both the Parties shall keep each other indemnified against all actions, suits and legal proceedings and against all the costs, charges, expenses, loss or damages, which may be incurred or suffered by the Parties due to any breach, default, contravention, non-observance or nonperformance by the Parties of any terms and conditions under this Agreement.
6. That in event of breach of the terms and condition of this Agreement by **ST. XAVIER'S COLLEGE, Mahuadanr,** **INDIAN INSTITUTE OF SKILL DEVELOPMENT PVT.LTD.** reserves right to terminate this Agreement by giving one (01) month's written notice to **ST. XAVIER'S COLLEGE, Mahuadanr,** and same right shall be applicable on **ST. XAVIER'S COLLEGE, Mahuadanr,** to terminate this Agreement by giving three(03) months' written notice to **INDIAN INSTITUTE OF SKILL DEVELOPMENT PVT.LTD.**
