
Subject: Construction of Basketball Court for the Students




Subject: Providing Alternative Energy through Solar Power Plant



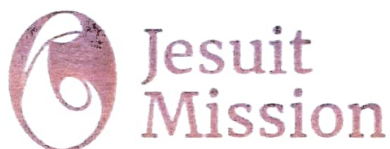

- Each organisation's vision, mission¹, values, policies and procedures;
- Jesuit Mission funding guidelines;
- Ignatian charism, the way of proceeding and Catholic Social Teaching principles;
- Local, international and Australian laws and regulations

This agreement helps to ensure that our partnership is centred on the dignity of God's most vulnerable people whilst working to achieve the project objectives and outcomes. Jesuit Mission reserves the right to review the partnership if project activities are inconsistent with the guidelines and details below.

From time to time Jesuit Mission staff and/or contractors may initiate a spot check of project finances, especially where Jesuit Mission has not received accurate financial reports in the agreed timeframe.

Project Name: St Xavier's College Mahuadanr (SXCM) Auditorium Construction and Fit-Out

Approved Budget: AUD 809,552

Main Project Objective: To build a new auditorium that will allow for the growing number of students at SXCM to gather in one place for functions and conferences. It will be a stand-alone building on the 18-acre campus of SXCM. With capacity for 1,300 people, the auditorium will cover 1,940 square metres.

5. Arrange and fund external program evaluations and audits (e.g. reviews of project finances and/or organisational policies and procedures in relation to areas such as safeguarding, fraud prevention, internal controls) where deemed necessary.
6. Contribute to the capacity strengthening of Hazaribag Jesuit Education Society staff when requested and/or agreed it is necessary. Type of support and training may include Jesuit Mission guidance; sharing and learning opportunities with similar Jesuit Mission partners; or locally sourced expertise and experience.
7. Reply promptly to correspondence, requests and enquiries.

Hazaribag Jesuit Education Society undertake to:

8. Use the funds provided solely for activities as described in the agreed project proposal and budget.
9. Where project plans need to be adjusted (activities, timings, budgets, target beneficiaries etc), communicate this to Jesuit Mission promptly.
10. Seek approval from Jesuit Mission if funds need to be reallocated to different activities (budget lines) for amounts over US\$5,000 or 10% of total project commitment (whichever is lower).
11. Acknowledge receipt of funds within seven (7) days of the money arriving.
12. Provide Jesuit Mission with the following reports:
